The acquisition and integration of GTS Central Europe's International Services Business Unit (IS BU) into Deutsche Telekom's International Carrier Sales & Solutions (ICSS) organization has now been finalized. By merging the two strong wholesale forces, ICSS is able to provide superior network coverage and a comprehensive portfolio of telecommunication products and services across the entire Central and Eastern Europe area, all from one source.

The integration has added a colossal 25,700 kilometers of fiber network connecting several thousand households in Poland, the Czech Republic, Romania and Hungary. This makes it the only operator in the area with such an extensive fiber optic network and augments its existing 200,000 plus kilometers connecting Europe, North America and Asia Pacific.

THE ONE-STOP-SHOP MODEL

Obtaining comprehensive solutions out of one hand makes it easier for customers to take advantage of extended solutions, a broader network footprint, as well as faster implementation times. In addition, with one contract, one SLA and one interconnect, business processes are optimized and more cost-effective. Deutsche Telekom clients now have access to the local networks of a number of CEE countries without the necessity of obtaining contracts in every single country or building up and maintaining their own infrastructures.

WIDENING THE FOOTPRINT OF ICSS COVERAGE

The ICSS global network has been significantly expanded by the acquisition of the GTS unit. The move has also given ICSS access to 14 of GTS's data centers across key CEE countries. This includes a 13,000 square meter facility that covers Warsaw, Prague, Ostrava, Brno, Bratislava and Budapest. ICSS now additionally leads the way in the Ethernet area in the region, where it also offers IP virtual private networks, Direct Internet Access and SDH solutions.

Via DTAG ownership ICSS has local infrastructure, and can deliver own last mile coverage in Poland, the Czech Republic, Slovakia, Hungary, Romania, Croatia, Greece and Germany. Since the management of handover points is achieved centrally and only one data center handover is needed to obtain access to the entire ICSS network, customers benefit from optimized

cost structures. Location in these countries are offered on a fully redundant basis, while in other CEE countries ICSS offers premium coverage via local partners.

A RICH PORTFOLIO OF SERVICES DRIVEN BY A HIGHLY SKILLED TEAM



Supervision of all traffic over ICSS's entire global network is handled by Deutsche Telekom's International Network Management Center (INMC) in Frankfurt am Main, Germany. Highly trained technicians oversee and supervise this ultramodern facility around the clock, 365 days a year. They are able to spot potential faults and take direct action to overcome problems.
